Termination of old clerk- Stacy Larson resigned at the end of May 2025, at the last meeting on May 16<sup>th</sup>, 2025.

Resident Communication-email access- Mary Keyes would like to have an email communication sent out to resident for boil orders, the agenda, and any other notification that regularly is posted on the Post Office Board and Door, and both doors of Town Hall. We will discuss more details on the matter next meeting. Those type of notifications will still be located at the post office and town hall.

Signatures -Eddie Becker motioned for Chanzi Oulds and Brendan Houder to be added to the signature and Stacy Larson will stay on until resignation. Louis Hulstine seconded the motion passed all in favor.

New ordinance request about conflict of interest- new ordinance would not allow any employees to work for the town and be on the board. Board members think we do not have enough citizens trying to work for

us to put in place an ordinance like this. Previously, we did not have a maintenance man or waste/water operator employed by the town. In turn we had to employ board members for task to be done. Ordinance may hinder us from getting important items done.
