Guest comments:

Old Business:

Water Project – GMS- are looking into getting started on fixing the nitrates in the water first. Cost estimates put together minus the meters. Cost estimate \$3,150,000. We may have to go through an archaeologist because of where the line would need to go. If we don't have GMS come out and get a plan together, we will have to wait until next year. We will discuss having GMS out December 2nd, 2025.
